## **INSIDE INFORMATION ANTICIPATION OF SUBSTANTIAL DECREASE IN LOSS**

The announcement is made by Beijing Digital Telecom Co., Ltd. (the “**Company**”, together with its subsidiaries, collectively the “**Group**”) pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and the Inside Information Provisions (as defined in the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The board of directors of the Company (the “**Board**”) hereby informs the shareholders and potential investors of the Company that, based on the preliminary review of the Group’s unaudited consolidated management accounts for the year ended 31 December 2022, the Group expects to record a revenue of not less than RMB13,000 million for the year ended 31 December 2022, as compared to a revenue of approximately RMB10,244 million for the year ended 31 December 2021; a net loss attributable to owners of the parent of the Company of not more than RMB280 million during the year, as compared to a net loss attributable to owners of the parent of the Company of approximately RMB3,567 million for the year ended 31 December 2021. The relevant changes are mainly attributable to (i) the Company continued to implement cost control measures and enhance efficiency in management, resulting in significant overall operating economic benefits during the year; and (ii) the asset impairment losses and non-operating expenses decreased significantly for the year ended 31 December 2022 compared with those for the corresponding period in 2021.

The Board hereby reminds the shareholders and potential investors of the Company that, as the Company is still in the process of finalizing the annual results of the Group for the year ended 31 December 2022, information contained in this announcement is only based on the preliminary assessment by the management of the Group on the basis of the unaudited management accounts of the Group and other information available for the time being, and such information has not been audited or reviewed by the auditors of the Company. The Company will announce its audited annual results for the year ended 31 December 2022 as soon as practicable in compliance with the Listing Rules.

At the request of the Company, trading in the H shares of the Company has been suspended with effect from 9:00 a.m. on 4 June 2021 and will remain suspended until further notice.
